

- 1.We recommend the reflow temperature 245°C(+/-5°C). The maximum soldering temperature should be limited to 260°C. 2.Don't cause stress to the epoxy resin while it is exposed 2. Don't cause sites to the epoxy resin while it is enter to high temperature.


